### This investment may be right for you if:-

- You are a **retail investor with a good level of knowledge regarding the financial markets and financial instruments and understand the specific factors including the risks highlighted in the literature provided to you.**
- You are looking for **income paid Semiannually**, linked to the performance of the **underlying assets (American Airlines Group ViacomCBS Inc Helmerich & Payne Inc LUKOIL PJSC MMC Norilsk Nickel PJSC )**
- You understand that on a Semiannually basis, on any given observation date, **if any one of the underlying assets is below 65,00% of their initial level, there will be no coupon for this payment period.** However, if the affected underlying asset recovers back to at least 65,00% of its initial level and the other underlying assets in the basket are at or above 65,00% of their initial level the previous missed coupons will be paid including any other coupon due
- **You are looking to risk your capital, and in the event of the product not performing as anticipated, you will receive** the amount of the product of the Current Price of the Worst Performing Share and the Volume within 5 Business Days from the Maturity Date.
